INCIDENT SUMMARY:

*******Update 5/12/2016 at 5:00pm*******

Detectives from the Pembroke Pines Police Department have been actively working the homicide of Miami Dade Corrections Corporal Daveon Hall. On Wednesday May 11, 2016 the case was presented to a Broward County Grand Jury. The Grand Jury returned an indictment charging Brian Fairweather and Ockeeve Sinclair with First Degree Murder.

Brain Fairweather remains in custody at the Broward County Jail.

On today's date Ockeeve Sinclair was located in Fort Pierce, Florida, and taken into custody.

This case remains an active criminal investigation and no further information will be released at this time.

*******Update 04/26/2016 at 5:00pm*******

Detectives from the Pembroke Pines Police Department have been actively working the homicide of Miami Dade Corrections Corporal Daveon Hall and have developed probable cause for the arrest of a suspect in this crime. On 04/26/2016 the suspect, Brian Fairweather, was interviewed at the Pembroke

Pines Police Department and upon completion of the interview was subsequently charged with the following criminal offenses:

Count #1 : First Degree Murder

Count #2-4: Possession of a Fictitious Drivers License

Count #5: Driving Without a Driver's License

Mr. Fairweather was transported to BSO Main Jail.

Currently, the investigation has not led to any indications that the victim was targeted due to his affiliation with Miami Dade Corrections.

A copy of the probable cause affidavit accompanies this release.

This case remains an active investigation and no further information will be released at this time.

At 5:36 pm on Friday, January 29, 2016, units from the Pembroke Pines Police Department responded to the above area. Upon arrival a deceased adult male was located within the residence.
