- Artists must be 18 or older.
- Submit: **3 high quality photos** of your work, 3 of your work in progress & 1 photo of your outdoor display labeled with your name. CD's with images are also accepted.
- Submit 2 checks: one for mandatory Jury Fee and one for Booth Fee.

- **Application Deadline:** No application will be accepted after March 3<sup>rd</sup>, 2017 at 5:00 p.m.
- Make checks payable to the *City of Pembroke Pines*.
- **The Jury Fee is non-refundable.** Jury Fees will be deposited upon receipt. Refunds of Booth Fees will be given only if requested in writing and received by January 30<sup>th</sup>, 2017. **Refunds will not be issued due to inclement weather. The Art & Crafts Festival will take place rain or shine.**
- Artists will be notified of their acceptance via e-mail after January 30<sup>th</sup>, 2017.
- Artists approved after February 3<sup>rd</sup> will **NOT** be advertised in the Art & Crafts Festival booklet.

## ART FESTIVAL RULES

- Artists shall comply with all applicable rules, ordinances, codes, statues, laws and regulations.
- Artists may only sell what is approved on the application.
- All work must be **ORIGINAL** handcrafted, created and exhibited by the artist. Kits, imports and mass produced items will not be accepted. **NO BUY / SELL.**
- Representatives of the Arts and Culture Advisory Board will visit your booth to review your art pieces, crafts and set-up during regular Festival hours.
- Artists shall remove any articles that are not in compliance with the criteria set forth in the artist application when notified by the City.
- The City reserves the right to remove any questionable artwork from view and close the display without compensation.
- The approved artist must occupy his or her booth at all times. Booth sitters will be provided for short breaks.
- Artists are required to collect the State Sales Tax (6%) and file a report with the Florida Dept. of Revenue.
- Artists must use their own means of display including a white, flame-retardant tent. Staking into the pavement will not be permitted. **Tents must be weighted down.**
- Displays must be professional and aesthetically pleasing. All racks must be covered. For sale signs are prohibited.
- RV space will be provided; electricity not provided.
- **SHOW SET-UP:** on Friday, March 10<sup>th</sup> from 3:30 p.m.- 7:00 p.m. or Saturday, March 11<sup>th</sup> with set-up completed by 8:30 a.m. Tardy artists will not be permitted onto the Festival grounds after 8:00 a.m.
- **SHOW BREAKDOWN:** on Sunday, March 12<sup>th</sup> from 5:00 p.m. – 8:00 p.m. Cars will not be permitted on the festival grounds until streets are cleared of all pedestrians.
- The City of Pembroke Pines has the right to modify or amend the Art Festival Rules without notice to the artist, as necessary.
