1. Signed and fully completed two page application.
2. Must include a letter of approved action from homeowners association (if applicable)
3. A sketch or map indicating the location & number of trees slated for removal / relocation.
4. At least one color photo of each tree being applied for. Attach additional photos as needed.
5. Provide photos of the front, back, and side yards to account for all existing landscaping.
6. Check, money order, or payment online with appropriate fees (see page 2).
7. A copy of the notice of code violation (if applicable).

**IV. Inspection Guidelines:** All applications will be reviewed by staff within 10 City business days from the date the application fee was processed. Applicants will receive a determination of approval or denial via Email and the US Postal Service after inspection occurs.

An inspection will occur a minimum of 90 calendar days after the issuance of the permit to ensure compliance with the terms of the permit. Permit expires 90 calendar days after issue date. Permit extensions must be requested by the applicant in writing and will be reviewed on a case by case basis.

**V. Application Fees (Non Refundable)**

Detached Single Family – \$25.00 (Effective October 20th, 2022)

Multi-Family or Commercial - \$50.00 for up to 10 Trees, plus \$10.00 for each additional tree.

**VI. Additional Requirements:**

**The submission of this application does not authorize the removal of trees. Work may not be performed until the application is approved and a permit is issued.** All applicants must contact Sunshine-811 by dialing 8-1-1 to have the property marked for underground utilities that may be affected by the removal/installation of the tree(s).The property owner or owner’s representative certifies, understands and will comply with the provisions and regulations of Ch. 155 of the City of Pembroke Pines Code of Ordinances. All work will be done in compliance with all other applicable laws and regulations including stump removal and grinding.

The property owner/owner’s representative certifies that the information provided and all attached, drawings, photos and/or maps are true to the best of their knowledge and any false/ incorrect information can result in the revocation of the permit and/or could also result in fines and/or charges.

**IF A TREE IS REMOVED, A REPLACEMENT MUST BE INSTALLED WITHIN 90 CALENDAR DAYS.**
