Membership Rules and Regulations

The Pembroke Lakes Golf Club is owned by the City of Pembroke Pines and managed by Professional Course Management, Johnny LaPonzina, President. Memberships are non-transferable and renewable annually at the discretion of management. Violation of any rule, regulation or non-payment of dues shall constitute cause for suspension and/or termination of membership and privileges. Under no circumstance shall there be any refund of any portion of the membership dues and/or service fees. All persons submitting application for membership, acknowledge by their signature, that they have read, accepted and shall abide by the terms and conditions described in the rules and regulations.

Member Cart Fees - \$30 plus tax

1. Members of all classifications have the privilege of reserving starting *times up to 10 days in advance of the date of play.*
2. Guests of Members will receive the lowest applicable rate offered. Guests MUST be accompanied by the Member to receive this rate.
3. Due to insurance and safety requirements, Junior Members must have a Valid Driver's License to operate golf Carts. *Note: Junior Members may ride with adult golfers for a member cart fee of \$30. Junior members are allowed to walk for no charge after 3pm daily.*
4. Nine Hole golf rates are available for Members only, Nine Hole members cart fee is \$19 per Member.
5. Raincheck Policy: No rainchecks will be issued unless, in the opinion of Management, conditions warrant the closing of the golf course. No refunds.
6. Management reserves the right to refuse service when it is in the club's or customer's best interest.
7. Management is not to be responsible for damage or loss of Members and/or guests personal property.
8. All persons entering the premises or using the facilities do so at their own risk.
9. Members shall pay for any loss or damage to the Club property for which they or their guests are responsible.
10. Employees are not to be reprimanded by Members or Guests. Complaints and suggestions shall be addressed to management.
11. Carts must be kept on the paths around Tees and Greens. Carts are not permitted on fairways that have been roped off or marked as "Cart Path Only". No Golf Carts are allowed in the parking lots.
12. Range Balls are not permitted on the golf course at any time.
13. Private coolers are not permitted on the Golf Course.
14. Players stopping between nines or anytime during the round must get permission from the starter to resume play.
15. Fishing is not permitted on the Golf Course.
16. No Fivesomes are permitted.
